#### 1. Foreword

This call is published within the **project "EUROSYN - Improve innovation services for SMEs by enabling synergies between R&D&I European funds**", carried out by **Friuli Innovazione** (Italy), **FTI Burgenland** GmbH (Austria) and **KEPA - Business & Cultural Development Centre** (Greece), three innovation agencies supporting SMEs in their competitive development processes.

The **project objective** is to better support SMEs in exploiting **synergies** between European structural funds, Horizon 2020 and other funds **for research**, **development and innovation activities**.

## 2. Objectives and purpose of the call of applicants

This call for applicants aims at selecting 15 Small and Medium-sized Enterprises (SMEs) from the three participating Regions, to be involved in the project pilot action.

In particular, a **customized Innovation Audit will be developed with each SME**, in order to **analyse the research and innovation projects ideas/needs** and **give indications on how to finance better their investments by exploiting synergies among different funds** at regional, national and European level.

## 3. Eligible entities

**In order to be eligible for the Innovation Audit** within EUROSYN Project, companies should fulfill all the **following requirements**:


• be a **Micro or Small Enterprise** according to the definition of the EU recommendation 2003/361<sup>1</sup>;

• be established in **one of the Regions involved in the project**: Friuli Venezia Giulia (Italy), Burgenland (Austria), Central Macedonia (Greece);

• operate in an **industrial/productive sector** - ICT included (consultancy firms and service providers - e.g. tourism, creative&cultural, social enterprises - are <u>not</u> included) and **be involved in Research and Innovation activities**.

## 4. Opportunities

Participation in activities is **free of charge**.

The project offers to SMEs the **opportunity** to take part in the project pilot action and receive:

- **tailored individual innovation audit** on their research and innovation projects ideas/needs;
- indications on how to exploit better different financing programmes at regional, national and European level in order to develop their R&D&I projects;
- an opportunity **to participate in the regional local workshops** (presenting the EUROSYN project's results) and **to present their innovative projects** to local stakeholders and relevant policy makers.

## 6. How to apply and deadline for submission of applications

Interested companies must fill in the attached Application form and send it by e-mail to tommaso.bernardini@friulinnovazione.it no later than Friday 31<sup>st</sup> March 2017 with the following object "Participation to EUROSYN pilot action".









## 7. Criteria, methods and evaluation procedures

Once eligible criteria have been checked, the **selection process** is based on the **arrival of the application** (*on a first-come, first-served basis*).

The selection results will be **communicated via e-mail** to SMEs which applied to the present call for applicants by the 6<sup>th</sup> April 2017.
